May 25, 2013

The PMPO Board meeting was convened about 1:30 PM May 25, 2013, following the Annual Meeting, at the Palomar Mountain Volunteer Fire Department. The Treasurer's and Secretary's reports were deferred.

#### **Election of Officers**

#### **Agenda items:**

Topic of discussion: ongoing contract negotiations between San Diego County and the Palomar Mountain Volunteer Fire Department regarding control, staffing, and potential impact on fire service and response. Yvonne Vaucher suggests we mail out a one-page summary of the issues facing the Palomar Mountain Volunteer Fire Department in the context of the San Diego Fire Authority. Rosemary Johnston moved the PMPO send a letter to the county Board of Supervisors expressing support for the PMVFD. Seconded by Robert Carlyle, approved unanimously.

Michael Walsh considers how to get the media on our side and understanding local concerns like fire insurance. George Evangelou says that fire protection shades into an eminent domain situation, if the county actions make property uninsurable. George Lucia says that six other San Diego county volunteer fire departments have not signed contracts with the Fire Authority, and six others have dissolved. George Evangelou moves we authorize up to \$300 for preparation and postage for a mailing to the PMPO newsletter list of a letter informing members of the issues, and what the PMVFD Board and the Chief's position is. Seconded by George Lucia, approved unanimously.
